

FORM OF A CONSENT TO PERSONAL DATA PROCESSING IN THE PROCESS OF RECRUITMENT

- The Data Controller of your personal data within the scope comprised by the present consent is 3A Composites Mobility S.A. with its registered seat in Mielec, address: Inwestorów 6, 39-300 Mielec, the company entered to the register of entrepreneurs kept by the District Court in Rzeszów, XII Commercial Division of the National Court Register under the number KRS: 0000396425, having National Business Registry Number (REGON) 180141815, tax identification number (NIP) 8172019840, share capital paid and registered: PLN 4,124,000 (hereinafter referred to as 'the Controller')

If you express consent to use, by the Controller, of your personal data, they will be processed (i.e., *inter alia*, gathered, stored, recorded, surveyed) by the Controller on the basis of your consent (as of 25th May 2018, also on the basis of article 6 section 1 letter a) of the Regulation protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC) for the purposes of recruitment.
- 3. By ticking the following points and signing the present document at its bottom, you express the consent to processing, by the Controller, of your personal data for recruitment purposes. Expressing the consent is voluntary. Each of the consents is separate from the remaining ones which means that you do not have to express consent to data processing for each of the purposes indicated below. If you do not express the consent to processing of your personal data for the purposes of recruitment, you will not be included in the process of recruitment. If you do not express the consent to processing of your personal data for the purposes led by the Controller and you express the consent to their processing for the purposes of the current recruitment, your personal data will be processed solely for the purpose of performance of the current recruitment.

Please remember that you have the right of insight into your personal data, as well as the possibility to correct them or to demand their removal, the right to demand from the Controller the access to your personal data, their correction, removal, limitation of their processing, transfer of the personal data, as well as the right to submit a complaint to the President of the Personal Data Protection Office. Rules of exercise of these rights are determined by legal

Please remember that the withdrawal of the consent to data processing remains without any impact on conformity of processing rendered on the basis of such consent before its withdrawal with the law.
- 8. Your personal data will not be processed in an automated manner.
