

## Privacy Policy „Cookies” notice

### I. General information

The Administrator of the website <https://3acompositesmobility.com/> is the company under the name 3A Composites Mobility S.A. based in Mielec, address: u. Inwestorów 6, 39-300 Mielec. Contact with the Administrator is available at the following e-mail address: kontakt.mobility@3acomposites.com

### II. Administer personal data

The User may transfer his personal data to the Administrator using the contact form available on the Website. Data provided to the Administrator as part of the contact form (i.e. e-mail address, name and telephone number) are processed in order to take action included in the form.

In addition, the User may transfer his personal data to the Administrator using an e-mail sent to the Administrator's addresses shared on the website or by phone, contacting the phone numbers provided on the website.

Providing data is always voluntary, yet necessary for the User to take action, to which the form is provided or to fulfill the request contained in the e-mail addressed to him, e-mail sent to the address / addresses provided on the website or to fulfill the request contained in telephone conversation. The Administrator processes the personal data obtained in this way, based on art. 6 par. 1, b GDPR (RODO). In addition, the Administrator will process the acquired personal data:

- a) to provide electronic services and enter sales contracts - the legal basis for personal data processing is art. 6 par. 1, b GDPR (RODO),
- b) to target marketing content - the legal basis for personal data processing is the legitimately justified interest of the Administrator, art. 6 par. 1, f GDPR (RODO); the legitimate interest of Administrator means sending the marketing content to the User, during the period of providing services to the User, by electronic means, by post and additionally in a manner for which the User has agreed,
- c) in order to direct marketing content based on the User's consent - the legal basis for personal data processing is art. 6 par. 1, a GDPR (RODO);
- d) to send a newsletter to the User, for which the User has agreed, the basis for personal data processing is Art. 6 par. 1, a GDPR (RODO);
- e) for the purpose of fulfilling the legal obligations on the Administrator's site on the basis of generally applicable laws, including tax and accounting regulations - the legal basis for personal data processing is art. 6 par. 1, c GDPR (RODO),
- f) for analytical and statistical purposes - the legal basis for personal data processing is the

- legitimate interest of the Administrator Art. 6 par. 1, f GDPR (RODO); the Administrator's legitimately justified interest means analyzing the results of the business,
- g) in order to implement the legitimate interest of the Administrator, meaning stating or pursuing claims or defending against claims - the basis for personal data processing is a legitimate interest of the Administrator - Art. 6 par. 1, f GDPR (RODO)

Providing personal data is voluntary, yet necessary - except for data processed for the purpose set out in point 3 (b), (c), (d) and (f) in order to execute contracts with the User. The consequence of not providing the personal data required to conclude or execute contracts results in inability to conclude a contract.

The Administrator might transfer personal data to recipients located in states outside of the European Economic Area (Switzerland). We will ensure that any such transfers take place in accordance with our obligations under the GDPR (RODO) and only by using appropriate cross border transfer mechanism.

On the other hand, the recipients of Users' personal data can be:

- a) IT systems providers and IT services,
- b) entities providing accounting services, service quality tests, recovery of receivables, legal, analytical and marketing services,
- c) postal operators and couriers,
- d) operators of electronic payment systems and banks to conclude payments,
- e) authorities entitled to receive your personal data on the basis of legal provisions.

The Administrator will process the personal data only until the action, to which the form is used, is completed or until the request made in e-mail is completed. In case when: (i) personal data are processed to conclude and perform contracts - for the time necessary to perform all obligations under the contracts, (ii) personal data are processed in order to send the marketing content to the User during the period of fulfilling contracts with the User - until the completion of the contracts (iii) personal data are processed in order to direct marketing content to the User on the basis of User's consent - until the User objects to his personal data being processed in this respect, (iv) personal data are processed in order to direct newsletters to the user, based on User's consent, until the User objects to his personal data being processed in this respect (v) personal data are processed by the Administrator on the basis of generally applicable laws - for a period of time required by applicable regulations, (vi) personal data are processed for analytical and statistical purposes - until the completion of the contracts, (vii) personal data are processed to state or pursue claims or to defend against these claims - until the expiry period of claims. After this period, personal data will be processed only legitimately and for the time required by law, including accounting regulations.

The Administrator will profile the acquired personal data of Users.

The Administrator guarantees the confidentiality of all personal data provided to him.

### III. Rights of a person concerned by the data

The Administrator pays particular attention to maintaining your privacy and protecting your personal data. As data Administrator, we care for the security of personal information that you have shared with us. This data is protected and secured against any access of unauthorized persons.

The user has the right to access the content of his data and the right to rectify it, delete it, restrict its processing, the right transfer data, including the right to receive data and send it to another Administrator or to request, if technically possible, to send the data directly to another Administrator, the right to raise objections (to the President of the Office of the Personal Data Protection), the right to withdraw the consent at any time without affecting the legality of the processing which was made on the basis of consent before its withdrawal. Withdrawal of consent does not affect the compliance with the law of processing carried out prior to its withdrawal.

### IV. „Cookies”

The Administrator uses cookies on the website, i.e. small text information stored on the User's end device (e.g. laptop, tablet, smartphone). Cookies can be read by the Administrator's computer system.

The Administrator stores cookies on the User's end device and then obtains the access to information contained therein for statistical and marketing purposes (remarketing) and to guarantee the proper operation of the site.

The Administrator informs the User that there is a possibility of such configuration of the Internet browser that prevents the storage of cookies on the User's end device. At the same time, we would like to inform you that in such a situation, the use of the Website by the User may be difficult.

The Administrator emphasizes here that cookies can be deleted by the User, after they are saved by the Administrator, through appropriate functions of the web browser, special programs for such purpose or by the use of appropriate tools available in the operating system used by the User.

The Administrator informs the User that he uses technologies tracking steps undertaken by the User within the Website through the Google Analytics tracking code - in order to analyze Website statistics.

Using the Website is synonymous with sending queries to the server on which the Page is stored.
